**INTER-CLUB COUNCIL TRUST & INACTIVE CLUB ACCOUNT POLICY**

**ARTICLE I**  
**NAME & PURPOSE**

**SECTION 1** The Inter-Club Councils of each campus will create a trust account to hold their funds in, and these trusts will be called the “Inter-Club Council Trust of Santa Rosa Campus” and the “Inter-Club Council Trust of Petaluma”, respectively.

**SECTION 2** These accounts will be separate from all Associated Students accounts, budgets, Trusts, etc. Money put into Inter-Club Council Trusts will roll-over each year, and be considered the property of each respective Inter-Club Council.

**ARTICLE II**  
**TRUST RESTRICTIONS & ACCESS**

**SECTION 1** ~~No funds allocated from the Associated Students budget may be placed into Inter-Club Council Trust accounts. This includes funds from the Associated Students Unrestricted Fund, and the Restricted Representation Fee (Fund 72).~~

~~**SECTION 2**~~ Funds kept in Inter-Club Council trusts may only be accessed when a proposal is made by a recognized club of the Inter-Club Council (of any SRJC campus) or any group or individual sponsored by an active club once approved by the council with a simple majority vote is made.

**ARTICLE III**  
**INACTIVE CLUB ACCOUNTS**

**SECTION 1** When a club remains inactive for four full consecutive semesters (excluding summer semesters), the club’s account funds will be deposited into the Inter-Club Council Trust account for their campus, and will be considered the property of that campus’ Inter-Club Council.

~~**SECTION 1**—All changes to this policy shall be approved by the SRJC Associated Students Senate after approval by each SRJC Inter-Club Council with a simple majority vote from within each of their governing bodies.~~

***Transitional Clause:***

*Upon the effective date of this Document, efforts shall be made to merge its contents with the **Inter-Club Council Bylaws**. With the Approval from the SGA, and the Petaluma Council (who serves as the Inter-Club Council for Petaluma) The Financial Maintenance of the Inter-Club Council Trust will be the sole Responsibility of the Inter-Club Council. Following its approval, this clause shall delete itself from this Document.*
