A. (Joshua Pinaula) SGA History, Budget History: I have lots of experience in this sector, this fee must be used for representation, not just anything that you wanted to use. By CA state law that is not

the appropriate use for this sector of the Budget

You cannot use the Student Center Fee to fund programs such as scholarships, you can make an argument with thing such as the PTK, but that would require discussion with people who hold very important positions. If those people don't like you you will not get what you want

The last thing is the CubCard Plus, this is a non mandatory fee, this is where all the money for unrestricted funds come. One can use unrestricted funds for different things. It is smart to promote this program because it is where we get money to do things that we want to do.

There are other things we should be focusing on besides fundraising, instead of scrambling trying to find money.

One thing I want to say that with all the shenanigans that we have done we have lost a total of \$35,000. If Eduardo is not constantly marketing for us we will lose money. In the last years we have lost \$50,000, it will surely decline this year. It was not a fun budget to pass but it is something that was worked on for years, decades, if we want to be like the other colleges how do we expect to do important things without the money. Consider the food pantry, because we have connections with local businesses we can give out lots of free food. You are going to have free food EVERY SINGLE DAY OF THE WEEK! Unless Eduardo (referring to marketing position), it is almost impossible to market in this way, we are going to keep struggling, and flushing money down the drain.

Q: Abril: Can you clarify what each section of the budget means?

- -Josh: Everything that you worked for and everything that you want to get accomplished or got accomplished, will get destroyed, we have to take into account everything that came before us, so the decision
 - 1. The student center Fee got passed: gave us a one time opportunity to make investments
 - 2. People's positions who have left, Sahara was with us for 30n years, by having these people under our employment

Lamont: Who is they?

Josh: Doug Roberts, you did great advocacy in the last board of trustees meeting

Gavin sorry to put you on the spot, you saved the military \$10 million, you are the most adequate person
