Sarah: If there is issues finding space, Shone Farm has a lot of space and also, could possibly provide food.

-Robert E: Make sure you give your full thought. "The students of SRJC have endorsed..." We represent about 3,000 student and we represent SRJC and our board of trustees and our president. It's a big decision and you have your choice.

-Abel Fernando: Has student government endorsed candidate in past?

-Robert E: They have endorsed Trustees but not outside of that.

-Jordan: How can we let students know? Post on social media, and we make sure we open up to the public to make sure we everyone has a say.

-Robert E: Make sure you pack your room to emphasize on our votes if we consider to endorse candidates.

-Jordan: It seems that we are in a grey area and it would be out of order to disappoint someone, but I'm announcing publicly that if they are not present in the next meeting it is going to be put into agenda to be disappointed

-Robert: *Announces Several Student Events *Jordan is going to be speaking publicly on Thursday

-Lamont: My mom bought a house so I will be on off campus 3-4 days a week so I will be taking online classes. If you need to get into contact with me let me know.

-Jordan: At the Adhoc committee it was stated that if you don't attend the implicit Bias there are grounds for disappointment

-Tabbitha: I am reading your By-Laws if a member wishes to resign you need to turn in a statement
