Minutes of the Executive Cabinet  
Meeting Held September 8

The meeting was called to order by President Hankins at 8:15 p.m. September 8, 1966. Those present were Rick Hankins, President; Linda Barrett, recording secretary; Kathy Bramwell, Corresponding secretary; Carol Sinclair, head songleader; and Mr. Canevari, also two members of the cheerleading team.

Those absent to the meeting: Ted Macklin, vice-president.

After a letter of recommendation by Rick Hankins was read by Kathy Bramwell. The letter dealt with the office of head cheerleader being vacant. Bob Zuck was nominated for the office by Carol Sinclair and the nomination was seconded by Kathy Bramwell. The nomination passed with a unanimous yes. The last paragraph of Rick's letter was discussed and it was decided that the songleaders would decide if the cheerleaders would be prepared to participate in the rally and game on September 16. The duties of the office of head cheerleader were discussed and Bob was told to advise the other members of the group of their duties.

Judy Simons was recommended for the office of Commissioner of Publicity to take Barbara's place. Rick read Judy's qualifications and interests and her position was then approved by the Cabinet.

The price boost for the first dance was discussed. The Commissioner of Dances, Dave James, asked that certain price increases be considered. The increase was proposed because the past dances did not show any profit. Rick Hankins placed in nomination the prices proposed, card holders- \$.25, students from other colleges- \$.50, night school students- \$.50, and guests- \$1.00. The motion was seconded by Linda Barrett. The motion passed unanimously. These prices will be asked for all the dances given this semester.

A resolution was made to make guests tickets available at anytime and at the door at the dance. Mr. Canevari suggested that a trial period of one or two dances should be considered. He also wanted to go on record as thinking that the Cabinet was creating problems. The dance committee will be responsible for the sale of guest tickets at the door.

A resolution to the ICC from the Inturium Committee on club selectivity was voted upon and passed unanimously. The Executive Cabinet goes in favor of the rules on club selectivity adopted from the Committee on club selectivity.

The meeting ended at 10 p.m.

- I. The meeting was call to order at 3:10 p.m. by President Rick Hankins.
- II. The minutes were approved as read. The agenda was approved as corrected.

- IV. Reports:

President Rick Hankins introduced the Dean of Women, Mrs. Pollard, and the Dean of Students, Mr. Dougan.

Parliamentarian, Bruce Parks, reported that all old club constitutions will be in effect until such time as the Student Assembly passes a measure to deal with the subject of selectivity. The reason for this decision was that ICC voted against the rules set down by the Board of Trustees, and that the constitutions could not be approved by Club Day. However, the clubs will be held responsible for complying to the Board of Trustees ruling.

Head Yell Leader, Bob Zuur, reported that SRJC students were cloud to attend the dance at Diablo Valley after the football game free of charge.

Jody Littleton, Elections Commissioner announced the dates of the Freshman Elections Assembly as Sept. 28, 1966 and the Freshman Elections as Sept. 30, 1966. Miss Littleton also encouraged all Student Body card holders to get out and vote!

Rick Lundeen, ICC Rep., reported that the American Censor Society awarded placques to Beta Chi, WLC, and Delphi for their contributions.

Mr. Lundeen also reported that ICC has rejected the Interum Rules.

Linda Mollenhower, Parking Committee Rep., reported a suggestion made by Mr. Anderson to have Student stickers for all those students who wished to park in the provided JC parking areas. The students would have to submit information such as registration and identification. It was suggested it become effective starting Fall 1967.

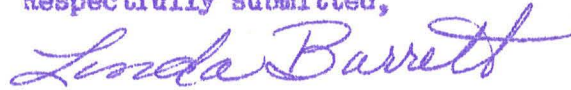
