- Any five students may be appointed to this commission instead of just certain designated officers and representatives.

A provision was made to review this commission in a year. At this time there is a possibility that further changes may be made.

John Merritt reported that we took in \$433.30 and made a profit of \$115.00 on last Friday's dance. This was the best we have ever done on a dance.

He also reported that the budget is very tight due to shortcommings on income from student body card sales and basketball games. We had expected to take in \$12,000 on card sales and \$400 from basketball games. However, only \$11,000 and \$200 was brought in.

Jim Brendlin reported that the Irish Rovers will be here tomorrow at 12:00 in the auditorium. He also has been working on the major assembly for April. He has received an estimate for Simon and Garfunkel, who charge \$6,000.

Richard Saarinen asked that an election committee be formed to rewrite the elections code. This will be taken up in Executive Council on Friday.

Carol Whitfield reported that "The Wheel" will play for the dance on February 24.

Steve Nienaber reported that the Board allocated \$300 for the student literary magazine "First Leaves". He also announced that he is resigning.

George Kiralthe reported that Club Day is Tuesday, February 21. The Tug-of-War will be held then at 12:00 near Bailey Field parking lot.

Mr. Canevari reported that if the ICC code fails here he will take it to the administration.

REPORT ON CJOSGA

ROLE OF FACULTY AND ADMINISTRATION WORKSHOP

The first question that I was confronted with when I returned from the State CJCSGA Conference in Los Angeles was, "It wasn't worth \$100 of the student's money to send you there, was it?" My reply was that it was probably not worth anything to those who did know there was such a thing as CJCSGA, there would be no benefit until there was use of the ideas, resolutions, and discussions that came out of the conference. As far as what I learned and experienced, I only ask, "How can you put a price tag on experience?" I am sure that I have had greater experiences for less money, but also that I have had far leaser experiences * spending much more money.

The things that I learned and experienced should be conveyed to the students. I hope that every student on campus will ask all five who attended this conference what ideas they got out of it. Only in this was are the students going to achieve real satisfaction and their money's worth. I hope the following will help these questions be asked and provide a reference for future convention delegates:

1. Keynote Speaker -- Dr. Melvin Casberg.

"The Ghallenge of Insecurity". This speaker was very well accepted, and started the conference off on a very good note. He challenged the audience of students to accept insecurity as a tool of thought and not as a crux.

- 2. Workshop Speaker -- Dean Wayne L. Allen.

"The Role of Faculty and Administration to Student Government." This speaker gave an audience of approximately 70 students the basis for study in our workshop. He spoke as an administrator, but seemed to understand that student's did have problems and that these problems must be dealt with, whether they be of a personal or general nature, whether they be along curriculum lines or of an extra-curricular nature."

3. Area 7 Caucus.

41

Unfortunately another Keynote Speaker, Edward Robings of Los Angeles Harbor College, did not maintain as did the one in my workshop and thus made some rather pert statements, unjustly founded, about Area 7, C.F.C., and Northern California and Bay Area students in general. His speech seemed to justify the original fears of Area 7-- that they were unwasted in CJCSGA. This meeting came up with no concrete ideas of retaliation, only moderation was suggested to combat the threats of the southern region.

4. The Role of Faculty and Administration to Student Covernment Workshop, (small colleges section).

This, I believe, was the highlight of the convention. In it we discussed issues within the topic that were pertinent to all colleges. Included in these discussions were: Dress Codes, student funds, student journahism censorship, curriculum, counciling and quidance, and the controversy of teacher evaluation. One of the most talked about points in this workshop was the fact that J.C. students have neither the time or the background (being at J.C. no more than 2 years) to be active participants in curriculum choices, class scheduling, admissions, probation of students and other areas 1 that administration and faculty can evaluate over a longer period of time. However, it was decided that having students on boards concerned with these problems would be of great assistance.

5. Tour of the Universal Movie Studios.

This tour proved interesting, but, in my mind, totally beyond the scope of a student government conference.

6. Workshop- combined large and small colleges.

Unfortunately our chairman, Sue Dockins of Long Beach City College, LAC, had neither the background nor the force to lead a profitable meeting. after one hour of worthless babble and parliamentary ping-pong, I walked out of this meeting followed by 4 other Area 7 colleges.

This workshop's purpose was to provide legislation for the following general assembly. Due to the chairman's lack of leadership and the debegates unwillingness to cooperate, this workshop only produced repetitious legislation and meaningless garble, in the general assembly of the following day.

7. General Assembly.

Because of a good chairman, electronic voting and prevoius workshop activity, this assembly passed in 4 hours approx 40 praces of legislation--a majority of it worthless trivia and legislation beyond the purpose of CJCSGA. There were, However, a few pieces that were well thought out (evaluation of these appear below).

EVALUATION

I firmly believe that GJCSGA can provide the services shat it promises in the Preamble to its constitution.

PREAMBLE

We the student governing bodies of California Junior Colleges; in order to provide an effective channel of representation for California Junior College students, to promote maximum communication among the local colleges and to offer junior college students an opportunity for democratic government in action for the benefit of the students and junior colleges of California, do establish and promalgate this constitution to establish a statewide Junior College Student Government Association. There were at this convention some resolutions beyond the scope and purposes of CJCSGA. I include here a few examples of such:

(Changing Student #10)

Resolved; That CJCSGA go on record as supporting the Beilenson Therapeutic Abortion Act, SB 462.

Resolved: That the CJCSGA go on record as favoring a reevaluation of the present narcotic laws.

(Fresidents #26)

Resolved: That the CJCSGA do on record of supporting the Free Mail Plan now in Congress.

(Presidents #8)

Sector Sector

I a not saying that there were not important pieces of legislation presented, but through discussion of some of those above, we did not have time for the "Student Rights resolution." This resolution is definitely within the scope of CJCSGA.

(Changing Student #7)

Resolved: That the CJCSGA go on record as favoring the adoption of student rights:

- 1. The right to a press free from censorship.
- 2. The right of students to take public stands on issues directly or indirectly pertinent to the junior college.
- 3. The right to form an organization around any particular interest.
- 4. The right of a student body to be informed of all matters concerning their respective colleges.
- 5. The right of students to participate with their administrations in decisions which affect their respective student bodies.
- 6. The right of student organizations to speak on any subject or to hear speakers on any subjects; and be it further

Resolved: The above rights may not at anytime violate State of Federal Laws.

There were a number of good pieces of legislation that did get a chance on the factor. The pass-fail system of grading and support of Assembly Bill 440 were among these.

Norkshop time was all too limited for thorough discussion of the topic and for clearly thought-out resolutions to be formulated. Perhaps, as I have implied before, these difficulties were only present in my workshop. However, after talking with others, I see an obvious need of more workshop time. It seems, from my observation, that S.R.J.C. should be in the larger college section of the workshop. College of Marin and S.R.J.C. throughout the problems discusses seemed to have the best situation of all. Where other colleges in the workshop had problems, Marin and Santa Rosa had what the workshop termed, the Ideal Situation.

It is for the above mentioned reasons that I propose the following recommendations:

- 1. That S.R.J.C. actively participate in C.F.C., to discuss issues pertinant to this area and outside the domain of C.J.C.S.G.A.
- 2. That S.R.J.C. incourage the leaders of GJCSGA to provide more workshop time, through the limitation of social activities to nighttime dances and a short afternoon "free-time", and that S.R.J.C. encourage CJCSGA to stay within the limits of Student Government and education discussion.
- 3. That S.R.J.C. continue active participation in Area 7 and send more than 1 representative to state only if Area 7 conference participation shows a need of sending a group of delegates.
- 4. That S.R.J.C. does not withdraw from State entirely at any time unless our representation there provides our Student Body and Student Government with absolutely nothing.
- 5. That S.R.J.C. when attending another state conference sit with the larger colleges in all divided workshops.

Pineo Delegate to CJCSGA State Spring 1967 ASB Parliamentarian Spring 1967 It is important for an individual involved in any sort of government organization to at least have some basic concept of a political philosophy. It has become approach from some of the charges leveled at C.S.A., and particularly those who represented C.S.A. and the student body at the recent C.J.C.S.G.f. Conference, that there are some very hazy concepts as to the accomplishments and aims of a government organization.

Government organizations are, by nature, bureaucratic and cumburson and the wheels of progress sometimes move with agonizing slowness. This is, of course, unfortunate but the alternative of the present time is reverting to a Thoreauain type of isolation. Our own American government has indeed tried isolation and thankfully have changed their position since World War I.

We here, at Santa Rosa Junior College, are faced at this time, with much the same problem. There are those among us who would have you believe that severing relations with C.J.C.S.G.A. and other colleges would be a boom to the student body because they, the students, would not be faced with the "over-burdening" taxation brought about by sending student representatives to the semi-annual C.J.C.S.G.A. Conference.

I question the validity of this argument, both on a monetary and idealogical basis. Monitarily speaking, the expenditure for both C.J.C.S.G.A. Conferences amounts to less than 2% of the annual budget, and the question must be immediately raised whether or not this amount is justified. I feel this expenditure is certainly justified, for it means the difference between a static student government and one which is truly dynamic and enlightened. C.J.C.S.G.A. and its subsidiary orgazizations offer the various student leaders throughout the states junior colleges, the only medium and forum through which an exchange of ideas can take place. This interchange of thoughts certainly does not justify student expenditure unless these ideas are brought home, and presented to the parent college, and then possibly, institution of these ideas take place. Instituting new ideas and policies is often difficult because of the maze of red tape one has to go through to make a college policy change; primary considerations are, of course, the drive of student government and the intelligent use of information gathered by the student leaders at the C.J.C.S.G.A. Conference.

The cries have been raised that this exchange of ideas is a fine and worthy project but that nothing dynamic ever happened on the campus after the C.J.C.S.G.A. conferences. I don't know whether this was because of apathetic student leadership or just a case of the faculty and administration negating all efforts the student leaders made in instituting new policies.

It must be clear to all members of C.S.A. that to pull out of C.J.C.S.G.A. would be one of the most serious and detrimental steps that this body could undertake. We as student leaders must always try to go forward and this is a virtual impossibility without the aid of C.J.C.S.G.A. C.S.A. as a single entity can institute nothing on a state level without the aid of our sister colleges, and I am afraid a college without a forum and ideas gained from other schools will be politically dead.

On a more specific basis, I feel the accomplishment of the state conconference for out weighed the minor irretants such as the will intentioned tour through Universal Studios. Even more specifically, I have brought back two ideas gained at the state C.J.C.S.G.A. Conference that I personally will try to institute with the help of C.S.A.

Of major importance was the idea of a Faculty Evaluation System, whereby students could know before entering a class what the instructor was like. Faculty "valuation might also serve to up-grade teaching methods and point out constructively some of the teachers failings.

Another important idea was that of having students serve on the curriculum board and thereby bringing to the attendion of faculty and administration courses not affered that might be in the future.

Both of these programs have a good chance of being instituted if C.S.A., the body politic, will join together and present rational and valid arguments to the administration.

CJCSGA Report CAMPUS CURRENT "The Impact of Tuition upon Higher Education "

Thursday night in my workshop the guest speaker was Dr. George Dotson. He presented both sides for the question on tuition, however he ended by taking a stand for tuition. Due to the late hour that was all that took place at this meeting. It seems that more interesting things were taking place in another workshop. Because of the speaker in Role of Campus Organizations Area 7 held a meeting to decide what action if any should be taken against what was being said about Area 7 and CFC.

Friday morning in my workshop we went through the agenda and discussed each item on it carefully. The topics that were covered are as follows: What is the role of free education in a democratic state? Is free education really free? To what level shall free education remain free? Under what circumstances should students pay? Who should determine policy regarding tuition? Are there any alternatives to tuition? If tuition were imposed, would students demand greater control and responsibility in the running of the school? Should tuition be charged at California State colleges and universities? What would be the effects of tuition at the state college and university level? on the junior college level? Will tuition change the educational principles of the junior college? What would be the effects upon the junior college "open door" policy? what would be the effects of tuition on the underprivileged students?

At II:30 the workshop was dismissed and that afternoon we went to Universal Studios. It was my feeling that this part of the conference was a complete waste. Due to the fact that we had much work and many resolutions to draw up and vote upon it seemed that the tour should have been forgotten. Because the tour took all of Friday afternoon we were unable to fininsh voting on all the resolutions.

Friday night we again met in our workshops to draw up and vote upon resolutions. In my workshop we presented seven resolutions to the general assembly. I will give the resolved clause and tell how I voted on it in the workshop, how SRJC voted on it in the general assembly and if it passed or failed. Resolution I: Therefore be it resolved that CJCSGA go on record as strenuously opposing any tuition changes at the California state colleges and universities (amended to read except out of state students). Voted yes all the way through. Passed. #2 Therefore be it resolved that the executive officers of CJCSGA set up a meeting with available State authorities to explain our position on the problems of tuition. Yes- #3 Therefore be it resolved that CJCSGA go on record in favor of augumentation of the present State Scholarship and aid programs both in number of students served and the types of costs covered. Yes- #4 Therefore be it resolved that CJCSGA go on record as supporting a revision of the state tax structure by placing more reliance on the progressive state income tax and a revamping of the regressive state property tax. We voted no, however it passed in the general assembly. #5 Therefore be it resolved that the CJCSGA go on record as favoring that the State of California establish a state lottery to produce income for education. de voted yes, however it failed on the general assembly floor. #6 Therefore be it resolved that the CJCSGA go on record as being in favor of the State of California increasing the financial support of higher education in accordance with the national average of 4%. Yes- #7 Therefore be it resolved that the CJCSGA

go on record as favoring a "living allowance" for potential but underprivileged students to allow them to begin or continue higher education: Therefore be it further resolved that the CJCSCA form a committee to study the factors of such a proposal. Yes-No-Failed.

Due to the tight schedule not all the resolutions were voted upon in general assembly. However the majority of the resolutions were voted upon. I believe that CJCSGA is an important part of our student government body and it would be a mistake to drop out. I was quoted as saying that I thought for the amount of work we accomplished at sate state it really wasn't worth it. 1. I shall attempt to report on the following paper the consequences and subsequences derived from my personal observations at the C.J.C.S.G.A. Conference.

2. Accomodations in Los Angeles were quite satisfactory, considering the physical practicality of accommodating representatives of 79 junior colleges.

3. I personally found the conference beneficial. Further, with what I learned, observed, and discussed with other delegates, I feel that the students of Santa Rosa Junior College will be ultimately benefitted.

4. I do not intend to list a schedule of the conference, or pages of sterotyped answers, since detailed information regarding the official program is readily available to all who are interested. Further, I do not intend to give any detailed information and comments regarding the "make-up" of resolutions and how the mass voted, and how Santa Rosa voted, as I think that this would be both time consuming and unnecessary. Rather, I would like to give somewhat of a personal philosophy.

5. Unfortunately, owing to an exceedingly demanding itinerary, without the benefit of enough time to fulfill the conference schedule, and further owing to an unnecessary, unjustifiable, but mandatory tour of Universal City, we did not complete the program as planned. This is really the only complaint I have against the planning of the conference.

6. I feel, that student government leaders, who are representing the students as a whole, either do an exemplary job as such, or a fairly poor job, depending upon the interest, insight, initiative, courage, wherewithal, and time and effort put into the office which they represent. It is truly unfortunate that the present administration has been so criticized; so accused of being incapable of recognizing that the State Conference is nothing more than "getting a short vacation from SRJC," (which must be fact, because the last administration said so); and misrepresented by that exemplary tool of flourishing words, that organ of "straight dope", our own Oak Leaf. This is not a rebuttal as such, just a personal comment.

7. I do not feel that the State Conference was in any way, shape, or form, a vacation from SRJC. The schedule was, for the most part, very demanding. My idea of a vacation is NOT getting up in the morning at 7:00 a. m. and trying to get to bed at about 2:00 a. m.

8. I attended the "Role of Campus Organizations" workshop. The recommended legislation that came out of this workshop was discussed, provoked, repressed, and many other things, prior to being recommended for approval or disapproval. Many, many ideas were exchanged, debated, well-taken, and discussed between the delegates of 79 junior colleges through-out the state.

9. The keynote speaker in the workshop that I attended, was a gentleman from Los Angeles Harbor College. He is the Dean of Student Activities at that college and a very intelligent man. Unfortunately, he was both misinformed, and misguided in his concepts of junior colleges in Northern California. He gave a speech that degraded the colleges in the area of California in which Santa Rosa is situated. He informed his audience that colleges north and east of San Francisco Bay consisted of "hippies," "happeners," and the like. I was personally outraged by these comments and practically violently opposed his captivating an audience and then misinforming them with such trash. After the 1st workshop (in which he gave his speech), I discussed at length with this man, Santa Rosa's resentment to such misleading information, and, to be succinct, set him straight. It was apparent that this man was representing the general resentment of Northern California Junior Colleges as felt by the South (Los Angeles). I feel that after approximately two hours of straightforward discussion with this man, that we (Russ Gleason and I), gave him not only food for thought regarding Northern California Junior Colleges, but a new respect for Santa Rosa Junior College in particular. It is my hope (and I feel that it will be realized), that he will take this new information back to his colleagues, and the resentment will be reevaluated.

10. Also, in the workshops, it became apparent to me, that Santa Rosa Junior College is indeed fortunate to have the things that we, as students often take for granted. When I told the delegates of 79 colleges of the Open Forum, Mid-Day Series programs, debates, Values in Life week, guest speakers, academic freedom, etc., etc., etc., that SRJC actively has on its campus, the majority of the representatives were amazed. It indeed made me feel proud that SRJC is such a superior college. What I'm leading up to is the fact that after discussing the programs that are promulgated on our campus, I have new insight, new ideas, new hopes, and in many cases, solutions to the representatives of those colleges that are not so fortunate as we. This alone made the conference worth our being there, and being represented, and our being heard as a strong and superior voice from the north.

11. Indeed, I agree with those persons of the delegation from SRJC who think that the State Conference should be "re-vamped." There are many things that could be done to make this conference a more effective one.

However, to "pull cut" of this conference would, at present, be disasterous. Instead, I feel that SRJC could work to make a more effective conference.

12. In conclusion, I should like to say that this is a very succinct report; not an exact one. To put down on paper all the resolutions, ideas, comments, and effects of the conference would take reams of paper. I am more than willing to discuss the conference with any member of the college community who wishes to discuss it and who is interested enough to take the time to talk with the student government representatives of Santa Rosa Junior College. To go one step further, I would heartily encourage any interested member of the college community to come in an see me - to discuss this conference and its effects, my opinions, or anything else relating to the conference.

May I begin my report by stating that I am strongly opposed to the suggestion by some to drop CJCSGA. I am a firm believer that nothing can be accomplished by quiting and that those who advocate such action have 19ttle desire to further the freedoms and advancements of our college and other educational institutions of our state.

The colleges of Notthern Galifornia are in the minority, due to the fact that more colleges are established in the more populated areas of our state around Los Angeles, but the thinking and problems on college campuses throughout the state are really the same. Here at Santa Rosa, and Area 7 as a whole, we enjoy the most liberal freedoms of speech, dress, assembly, and press, but unfortunately, this in not true in all colleges. This is why many such alarming and thought-probing resolutions from Area 7.put other conservative areas at illease. If Area 7 did nothing lese (which is untrue) it made the other colleges take notice and in some respects admire us. Area 7 with little hesitation, doveinto the evil table of controversial speakers, bithe control information, Black Power, tuition, and the war in Viet Nam. We brought to the state conference the real problems that face the college student and sought solutions for them. As the record will show, Area 7 resolutions were acted upon and the overwhelming majority of them passed. We were not black-balled by the South, but rather we cleared up the confusions of liberal thinking and demanded action.

When your delegates arrived at State, we were dhocked to learn we were thought of as "free love swinging hippies", and that we were nothing more than a communist political training camp 66r Cal Berkley. Through the efforts, thinking and actions of your delegates much was accomplished to curtail such misinformation.

The question has been raised of how the work of your delegates at Statw will benefit the whole student body. Also fears expressed by Mr. Doss, our former ASB President, that resolutions passed at State would be forgotten as in the past two delegations sent. I hope I may answer These questions and fears.

If sex on the college campus does not concern every student on our campus, then we are a unique campus. If drugs do not concenn us at SRJC, then we are blind. If the war in Viet Nam does not effect the student, then we are blessed. If Elack Power and the plight of the American negro does not concern the student, then we have little business in being in college and shapping our country's future. And if tuition does not concern every student on this campus, then they have been ignorant to the news media and the issues at hand. These are but a few of the resolutions passes at State and action on these issues is now in process.

Letters from CSA, myself, Mr. Canevari, our advisor, and our Beard of Trustees in favor of manditory student body cards, were sent to the leaders of State. Letters were also sent to the State conference concerning SRJC's, CSA's, and my own opinion opposing tuition.

Contacts with the Sonoma County Board of Health concerning birth control information were alos taken to State.

These were some of the problems which were acted upon at State and to which we at SRJC have shown our response. In my mind, the convention was a success, both for the delegates attending, the colleges involved, and the students deriving the benefits of the conference. I throughly am in favor of attending State as long as those attending have the same desire and attitude towards a fruitful end, as was shown by this year's delegates.

WHEREAS the Associated Women Students represents all women who are members of the Associated Students. Cards, letters or questionnaires shall be used to acquaint students with such membership; and

WHEREAS the Associated Women Students serve the general student body by providing opportunities for women to participate and work together for the common good of all students and by standing as a symbol of friendship, service and unity and by promoting a greater variety of activities on campus; and

WHEREAS a substantial number of the junior colleges in California have Associated Women Students that function under the guidelines being proposed here, and

WHEREAS one of the student representatives who attended the state conference reported that he had asked the representatives from other colleges about their A.W.S. program and was quite satisfied with the responses and as a result feels there is good reason to at least try this suggested program; and

WHEREAS other women's organizations on campus have been informed of the proposed changes and all are in agreement and willing to give support; and

WHEREAS the Executive Cabinet of C.S.A. is in favor of this proposal and is willing to allocate additional funds from the budget; and

WHEREAS the Associated Women Students pledge themselves to work hard at bringing new activities and programs to the campus in the fall such as Orientation Day for women, a guest speaker, Woman of the Month:

THEREFORE, be it

RESOLVED: that C.S.A. approve a change in status of A.W.S. from that of club to association and that C.S.A. approve the proposed Constitution and By-laws which will include a request that the A.W.S. President be a member of C.S.A. and that A.W.S. elections be held on the same day as C.S.A. elections.

PREAMBLE

Ind the Calland We, the Associated Women Students of Santa Rosa Junior College shall provide opportunities for women to participate and work together for the common good of our students and our college. We shall have as our purpose leadership, among women students in order that they may cooperate effectively in all college activities. We shall strive to stand as a symbol of friendship, service and unity and to provide a means of recognition for outstanding service.

ARTICLE I

NAME

This association shall be known as the Associated Women Students of Santa Rosa Junior College.

ARTICLE II

PURPOSE

The purpose of this association is four fold:

- To promote cooperation, leadership and self-government (a)
- To encourage service to others in the college and in the community (b)
- (c) To promote cooperation with other student organizations
- (d)To deal with problems concerning interests and needs of women in this college

ARTICLE III

MEMBERSHIP

All women students who are members of the Associated Student Body of Santa Rosa Junior College shall automatically become members of this organization and shall have the right to vote.

ARTICLE IV

OFFICERS - ELIGIBILITY AND DUTIES

- Section 1. The elective officers of A.W.S. shall be the President, Vice-President and Secretary.
- Section 2. The appointive officers shall be Treasurer, Historian and various chairmen as shall be deemed necessary from year to year.
- In order to hold an elective office in A.W.S. the requirements Section 3. are as follows:
 - To be a holder of a student body card a.
 - To have a 2.0 grade point average for the semester of election Ъ.
 - To be carrying at least 12 units during term of office с.

- Section 4 Nomination for elective offices -- Procedures are to be established by the Cabinet before the end of each semester or established in the by-laws
- Section 5 Elections shall be conducted at the time of the Associated Student Body election. Procedures are to be outlined either in by-laws or by cabinet at end of each semester.
- Section 6 The term of office shall in general be one semester
- Section 7 The President, if possible, shall have served previously on the A.W.S. cabinet
- Section 8 The duties of the President shall be as follows:
 - a. To preside over all meetings of A.W.S.
 - b. To appoint any temporary and standing committee necessary to carry out the work of the organization.
 Be ex-officio member of same
 - c. To make temporary appointments to fill vacancies
 - d. To act as chairman of the Executive Board
 - e. To act as official representative to the College Student Assembly when appointed by the Associated Students President
- Section 9 The duties of the Vice-President shall be:
 - a. To fulfill the duties of the President in her absence and shall assume the office in the event it becomes vacant
 b. To be in charge of all social affairs
- Section 10 The duties of the Secretary shall be as follows:
 - a. To keep an accurate account of the minutes of each meeting
 - b. To handle all correspondence pertaining to the organization
 - c. To report weekly the activities of A.W.S. to THE OAK LEAF
 - d. To file all minutes and records in the Dean of Women's office
 - e. To prepare the ballots for election

Section 11 The duties of the treasurer shall be as follows:

- a. To be in charge of the preparation of the budget
- b. To work with the Dean of Women in taking care of the finances of the association
- c. To be in charge of all ticket sales
- d. To submit the budget monthly to the Executive Board
- Section 12 The duties of the Historian shall be as follows:
 - a. To be responsible for keeping an historical record of all A.W.S. activities in the form of a scrapbook
ARTICLE V

EXECUTIVE CABINET

- <u>Section I</u> The Executive Cabinet shall consist of all elective and appointive officers, all major committee chairmen, representatives from women's clubs and Dean of Women.
- Section II Representatives of women's clubs shall provide communication between A.W.S. and their representative clubs, and shall help to carry out A.W.S. activities.
- Section III The Executive Cabinet shall meet at a specific time decided upon at the beginning of each semester. The council shall meet at least once a month.
- $\frac{\text{Section IV}}{\text{Executives.}}$ The business of the association shall be transacted by the

ARTICLE VI

By-Laws

By-laws must be presented one meeting prior to voting. They shall be passed by a two-thirds majority of the Executive Cabinet.

ARTICLE VII

Vacancies

Vacancies shall be filled through a cabinet appointment.

ARTICLE VIII

Faculty Adviser

The adviser for the Associated Women Students shall be the Dean of Women.

ARTICLE IX

Amendments

- Section 1. Amendments to this constitution may be proposed by members of the Executive Cabinet or upon written petition of 25 members of the Associated Women Students.
- Section 2. The amendment must have been presented to the members at a regular meeting at least a week before voting.
- Section 3. This constitution may be amended by a simple majority of those voting.
- Section 4. Amendments to this Constitution and By-laws must be approved by a simple majority of C.S.A.

ARTICLE X

ENABLING CLAUSE

This Constitution shall become effective when approved by a simple majority of the Board of Directors and a two-thirds majority of the total voting membership of this club and when approved by CSA and shall remain in effect until such time as a constitution replacing it shall become effective.

In view of the "sour grapes" statements expressed by the "Hankins Gives Up Post" article, I believe that the "worst violator" is the student who feels that it is his responsibility to run the SRJC Administration.

The realized "sickness" was simply one of the inability of the past president, Mr. Hankins, to have remembered that he was first a student that was <u>elected</u> to the office of Student Body president to represent the students in the SRJC Administration framework.

The organization of any large institution requires people who have had long-term experience, right down to the "clerks and secretaries". Big Business has spent thousands of dollars in research to avoid the "3 year term" just so that they would have people in their employment who "know the ropes".

A captain in office 8 months stamping his feet saying, "If I can't have my way, I won't play" is acting like a baby monkey who discovers he can hang by his tail from a limb, but doesn't know which direction to swing in.

Mr. Hankins wasn't required to resign his position due to pressures; he had to give it up. And he owes it to the Student Body public to explain that he had to resign because he did not earn the required two point grade average for the $10\frac{1}{2}$ units which he carried last semester. He didn't earn the right to keep the position. A college leader should first be a student, then should be big enough to take criticism, and third, should know his place. Moreover, his statements are not only in very poor taste, but are unprovable wherein he is casting shadows of doubt in the Administration's ability to hire, judge, and fire its employees, "clerks and secretaries" included.

The student body, as well as Mr. Hankins, paid a high price for his "turmoil"filled" office. The controversially diverting activities of last semester consumed valuable student study time without showing any significant results in the effect in student body government. Hopefully, the new President will be able to restore order from chaos.

Hankins' reasons for resigning his membership in the proposed Doyle Student Center Commission are not valid as presented on page 2 of the Feb. 9 issue of the Oakleaf. As reply to the Student Affairs Committee, Dr. Newman submitted a report which specifically outlined a ratio of 5 - 5 of faculty and students. This is not a "reversal" of the Hankins proposal of 5 students and 4 faculty members, but a stand for equalization of responsibilities and vote.

PARLIAMENTARY PROCEDURE

based upon Sturgis Standard Code of Vahliamentary Procedure

Introduction:

The basic reason for having any standard procedure is to dispose of the business before the assembly as quickly, efficiently, and justly as possible. The most important principles underlying parliamentary procedure are the following:

- 1. Parliamentary rules exist to facilitate the transaction of business and to promote cooperation and harmony.
- 2. The vote of the majority decides.
- 3. All members have equal rights, privileges, and obligations.
- 4. The minority has rights which must be protected.
- 5. Full and free discussion of every proposition presented for decision is an established right.
- 6. The simplest and most direct procedure for accomplishing a purpose should be followed.
- 7. Motions have a definite and logical order of precedence.
- 8. Every member has the right to know at all times what question is before the assembly and what its effect will be.
- 9. Only one question can be considered at a time.
- 10. Those to whom power is delegated must be ghosen by democratic processes.

Definitions:

- 1. Motion—A proposal submitted to an assembly for its consideration and introduced by the words, "I move that . . ." There are four types of motions.
 - i. Main motion a motion presenting a subject to an assembly for discussion and decision.
 - ii. Subsidiary motion a motion which may be applied to a main motion in order to hodify, delay or dispose of the main motion.
 - iii. Privileged Motion --- a motion affecting the comfort or convenience of the assembly or one of its members, and having the highest order of precedence.
 - iv. Incidental Motion-a motion relating to questions which arise incidentally out of the business, or order or manner of considering the business of an assembly.
- Pending A question is said to be a Pending Question when it is before the assembly and has not yet been voted upon. The Immediately Pending Question is the last question proposed when several questions are on the floor, and it is the first question that the assembly must decide.
- 3. Previous Question--A motion made to close debate upon a matter of business and to have a vote taken at once upon the immediately pending question. It requires a two-thirds vote and the correct form is, "Mr. Chairman, I call the Previous Question."
- 4. Put the Question- The Chair asks for a vote on the question seeing that there is no more relevant discussion on the question.

Method of Conducting Business by Sturgis and other parliamentary codes--

The most common means of introducing business to the gathered assembly is the notion. In the case of receiving committee reports, etc. it is no required to make a formal motion.

In order to make a motion, the speaker must be recognized by the chair. An example of the procedure of making a motion follows:

MR. A (rising and addressing the chair): "Mr. Chairman." CHAIRMAN: "Mr. A."

Mr. A: "I move that this club undertake a campaign to raise funds for the purchase of the property adjoining our clubhouse."

Mr. B (without rising):"I second the motion."

CHAIRMAN: "It has been moved and seconded that this organization undertake a campaign

to raise funds for the purchase of the property which adjoins our clubhouse. Is there any discussion?"

Discussion of the motion is then in order.

All motions should be addressed to the chair is similar fashion. Many motions do not need seconds and are not debatable. These motions along with all other motions are listed in order of precedence on the yellow sheet accompanying this leaflet.

Secondary motions to the main motions may be proposed and discussed. If a question incidental to the business arises, it becomes immediately pending question and must be disposed of before returning to the main motion.

Voting takes place when all debate has ceased. The chair asks, "Are you ready for the question?" If it is clear that no one objects, he then puts the question. Voting may take place in one of eight ways. The most important of these are: voice vote, rising vote, count vote(show of hands), roll call, ballot, and Unanimous consent.

This is just a small part of the many rules that must be followed in order to conduct a effective and orderly assembly. However, the codes of parlimentary law are flexible and may be changed slightly to elevate unwanted formalities in certain assemblies.

I refer anyone interested in the orgainization and procedure of assemblies to <u>Sturgis Standart Code of Parliamentary Procedure</u>. This will help you understand many of the things which I have not included here and some of the things that I have only lightly touched on. I hope that this paper will help you, in your meetings, to understand and simplify procedures and the handling of business. I would appreciate any questions on this or on <u>Sturgis</u> and its relationship to running your club, I.C.C., C.S.A. or other meetings.

PARLIAMENTARY PROCEDURE

Based upon Sturgis Standard Code of Parliamentary Procedure

Introduction:

The basic reason for having any standard procedure is to dispose of the. business before the assembly as quickly, efficiently, and justly as possible. The most important principles underlying parliamentary procedure are the following:

- 1. Parliamentary rules exist to facilitate the transaction of business and to promote cooperation and harmony.
- 2. The vote of the majority decides.
- 3. All members have equal rights which must be protected.
- 4. All members have equal rights, privileges, and obligations.
- 5. Full and free discussion of every proposition presented for decision is an established right.
- 6. The simples. should be followed. have a defined The simplest and most direct procedure for accomplishing a purpose
- 7. Motions have a definite and logical order of precedence.
- 8. Every mamber has the right to know at all times what question is before the assembly and what its effect will be.
- 9. Only one question can be considered at a time.

10. Those to whom power is delegated must be chosen by democratic processes.

Definitions:

- 1. Motion--- A proposal submitted to an assembly for its consideration and introduced by the words, "I move that ... "
 - a. Main motion -- a motion presenting a subject to an assembly for discussion and decision.
- ---b. Subsidiary motion - a motion which may be applied to a main motion in order to modify, delay or dispose of the main motion.
- c. Privileged motion -- a motion affecting the comfort or convenience of the assembly or one of its members, and having the highest order of precedence. ----
 - d. Incidental motion --- a motion relating to questions which arise incidentally out of the business, or order or manner of considering
 - the business of an assembly.
- 2. Pending --- A question is said to be a Pending Question when it is before the assembly and has not yet been voted upon. The Immediately Pending Question is the last question proposed when several questions are on
 - the floor, and it is the first question that the assembly must decide.
- 3. Previous Question -- A motion make to close debate upon a matter of business and to have a vote taken at once upon the immediately pending question. It requires a two-thirds vote and the correct form is, "Mr. Chairman, I call the Previous Question."
- 4. 4. Put the Question- The Chair asks for a vote on the question seeing that there is no more relevant discussion on the question. Maral Train

Method of Conducting Business by Sturgis and other parliamentary codes-

The most common means of introducing business to the gathered assembly is tth the motion. In the case of receiving committee reports, etc. it is not required to make a formal motion.

- In order to make a motion, the speaker must be recognized by the chair. An example of the procedure of making a motion follows:

-1-

Mr. A (rising and addressing the Chair): "Mr. Chairman." Chairman: "Mr. A."

Mr. A: "I move that this club undertake a campaign to raise funds for the purchase of the property adjoining our clubhouse."

Mr. B (without rising): "I second the motion."

Chairman: "It has been moved and seconded that this organization undera campaion to raise funds for the purchase of the property which adjoins our clubhouse. Is there any discussion?"

Discussion of the motion is then in order.

-

LAT LOUGHT COLOR

All motions should be addressed to the chair in similar fashion. Many motions do not need seconds and are not debatable. These motions along with all other motions are listed in order of precedence on the yellow sheet accompanying this leaflet.

Secondary motions to the main motions may be proposed and discussed. If a question incidental to the business arises, it becomes immediately pending question and must be disposed of before returning to the main motion.

Voting takes place when all debate has ceased. The chair asks, "Are you ready for the question?" If it is clear that no one objects, he then puts the question. Voting may take place in one of eight ways. The most important of these are: voice vote, rising vote, count vote (show of hands), roll call, ballot, and Unanimous consent.

This is just a small part of the many rules that must be followed in order to conduct an effective and orderly assembly. However, the codes of parliamentary law are flexible and may be changed slightly to elevate unwanted formalities in certain assemblies.

I refer anyone interested in the organization and procedure of assemblies to Sturgis Standard Code of Parliamentary Procedure. This will help you to understand many of the things which I have not included here and some of the things that I have only lightly touched on. I hope that this paper will help you in your meetings, to understand and simplify procedures and the handling of business. I would appreciate any questions on this or on Sturgis and its relationship to running your club, I.C.C., C.S.A. or other meetings.

SECTION 17. Candidates may use the Activities Office duplication machine at no cost.

SECTION 18. There will be no campaigning the day of election within fifteen feet of the polls.

SECTION 19.

No more than \$25.00, including contributions, may be spent for one campaign for each candidater

A. All candidates, or their campaign manager, must file in writing to the Election Commissioner within three weeks after the election a detailed report of expenses of their campaign.

B. No candidate for office may use photographs for campaign purposes.

C. If a candidate is found to have spent more than \$25.00, or has filed a false statement of expenses, or does not file a statement within one week after the election, this shall be sufficient grounds for either disqualification of candidacy or removal from office. In the event a candidate is removed from office under this Section, the provisions of Section 20 shall apply.

It shall be the duty of the Election Review Board to regulate campaigning and disqualify any candidate found by the Commissioner to be in violation of any rules or regulations of the Associated Students.

The Election Review Board, composed of Election Commissioner and two Representatives elected from C.S.A., will rule on any reported violation of the election code. If anyone on the Election Review Board is running for an office in the current campaign, a replacement will be appointed by the president of C.S.A.

- A. Any candidate disqualified may appeal the decision of the Election Review Board to the College Student Assembly within eight days after the decision of the Elections Commissioner. A two-thirds vote of the College Student Assembly members voting shall reinstate the candiate.
 - If a candidate is disqualified and then reinstated, but after the election, the President shall declare the election for the office void and a special election shall be held within ten days after reinstatement.
- B. The Elections Commissioner shall inform the President in writing of any protests of violations by any student to or on the Elections Committee, within twenty-four hours after the protest has been made.
