VP of Finance: Update on Revenue Status

Hector: Discusses various revenue accounts and current status

Revenue Account	Projected Revenue	Current Revenue (July 1 st – Nov 5 th)
Assoc Students (CubCard Prem)	\$78,000	\$39,521.50
Student Center Fee	\$100,000	\$41,916.29
Student Representation Fee	\$45,000	\$24,416.27

This is revenue that has posted to each account in Escape. There is still unposted revenue, outstanding fees from students that has yet to hit the budget. We also have spring and part of the summer semester to reach our projected revenue goal. Did not report on Transportation Fee.

Maybe the SGA marketing team can create promo materials to be put in the libraries, in the bookstore, Pacific Dining, etc. Melissa would like to connect with the Marketing and Communications department to help the students get more local businesses involved with the program.

Discussion: Hilleary's report on Transportation Fee and how it is currently spent

How much is the Transportation Fee: \$1 per unit, not to exceed \$10 per semester and up to \$5 for summer term. Fee paid by all credit students. The revenue from this fee is spent on SR City and SoCo County Transit totaling a little over \$150k total. **Pilot Programs:** SMART Day 31-day Pass, \$30k per semester, and Uber Shone Farm Uber Voucher Program \$25k per semester. Uber Shone Farm voucher was created because the current bus route stops on River Road, but does not turn down Trenton Road, which is a dangerous road to walk down to get to Shone.

Identified challenges in transportation for students; rising costs to contracts since they are based on ridership; schedules end too early for students taking late classes. SRJC collaborates with local and regional partnerships to advocate for students, i.e., MTC and SCTA.

SRJC vision for student transportation is to expand routes and schedule times and eco-friendly vehicles and long-term planning. Hilleary will be requesting from SGA to use more Transportation Reserves funds to cover more Uber Vouchers and SMART passes for the Spring semester.

A point was made to look into Golden Gate Transit as a possible contract that could get students to SF much cheaper than the SMART Train, central drop-off locations.
