## X. Special Reports (15 minutes per speaker):

#### A. West Below- Freedom Of Clubs Act

Presented official text amends ICC Constitution which modifies the Ad Hoc and removes the Club Advisor and endorsed the procedure district-wide. The champions of this bill are SRJC students to help all students who want to participate in a club or start a club or start any student group. This will greatly be beneficial and the bill will make a minor change. If clubs need to get money, they can do it on their own. Don't need a faculty from the college.

Advantage 1 – there will be more clubs on campus now that COVID is here and will be closed down rest of academic year. Now more important than ever to maintain the community at SRJC to social interaction to student promote mental health. Economic theory less regulation, the more fear this way will remove entry to be in a club. This bill will allow more student clubs on campus and more clubs to choose from. There will be more clubs involved.

Advantage 2 - more active students, especially hard for politically active clubs; oppose administration and leave faculty to approve all we do and attend meetings, represents a flaw in the system. We need more student voices in conversation at the JC and surrounding are more advocacy, equity, diversity etc. Advantage 3 - will make a principal change and not only practical. To not be micromanaged by faculty. Foster independence and entrepreneurial experience to move on to work load and foster these values will serve the JC mission and will be overall benefit to society.

Athena – what are our benefits you say is to make SGA look good? Benefits – all are politically active and would benefit from this change.

West - will remove barriers to create clubs and get more politically active on campus. Endorsing will help to pass through College Council and Board of Trustee. Also Inter Club Council has decided to endorse this bill. If SGA made the same decision would help as well.

Sarah Whylly – not opposed and have enjoyed to be Club Faculty Advisor. It is difficult to get students to get faculty to help with advising, not many are available. Two issues of concerns: False assumption of the economic period and the idea of clubs on campus. They are not in competition right now for membership, there is no monetary now, but the idea the clubs are there to attract students to interest. A competition model is fallacious. Secondarily, wonder what is the advantage. You mention the District administration and faculty – the bill removes the Faculty Advisory and does not involved the District; it is the faculty who choses to advise. You have 2 separate classes of employees.

West – economic theory – not saying economic in completion but in behavior and interact. To remove barriers for entry for a group, then there will be more groups and then it will be easier, also concerned differentiation of Faculty and Administration, either way both have power over other various degrees. Consider students as a separate group therefore they can act for student they represent. This is what he talks about in promoting this bill. Will benefit all students and SGA as they represent all students.

Evelyn – concern, there benefits faculty and staff and the knowledge they have, other individuals due to their work field and work other places. Also ask, where will this go after/if SGA agrees? This would need to be vetted by groups and brought to the Board of Trustees.

West – already endorsed by ICC pending SGA then will go to College Council and then to Board of Trustees who gives final approval. Benefits of faculty members advising clubs – each should be a choice and a club who may need a faculty to help them, then they can seek faculty to help; this is giving them a choice if

they want an advisor and if they are Ad Hoc if dealing with money. Should be optional, should be for the students and run by the students and opportunity for students to engage in leadership.

Sebastian. – would this allow current clubs get rid of their Advisor? Current Student Life at SRJC, started, created relationships with student and faculty. Hard to see a benefit to all students. Change with some advisors they bring their wisdom and guidance. The students come and go, and is up to advisors to take on the roll to pass on to next generation of students. A bit harmful to already existed students. Already has taken a lot to be inclusive and diverse. This does not make it right by moving the advisor and make more clubs come forward. Also, when removing an advisor, does not allow students to come forward and receive resources as a club. A bit contradicting, and is harmful to students and not helpful as a whole unit.

West – if a current club wants to go into as an Ad Hoc club then yes, this change would allow to move forward with no advisor. Disagree that faculty is needed for wisdom and with degrees and should be able to lead their groups themselves. If you want to have an advisor, go ahead and get one. Think this will help all students allows them to make more choices themselves and more choices we can make for yourselves better as a whole in society.

Joshua – with cadets how can they be monitored without an advisor? They need an advisor. SRJC is responsible for their students and assurance to students have an advisor.

If illegal concerns and students do illegal issues and then they will need to answer. This is a specific bill only applies for Ad Hoc club only a good test before it opens up to all clubs.

West – have not been left with a choice because they do not have an advisor. Recognized by the college you get marketing, and see you exist. Provide students with a choice if they need faculty advising and not forced to have others acknowledge their existence.

Sierra – clubs have done illegal activity at other college and concerned with the lacking an advisor with various activities planned on campus, then opens up JC up to litigation and oversite of people who have a responsibility.

West - Please endorse and make a motion for the bill as written.

Robert Ethington – 1<sup>st</sup> any discussion removing barriers is important. Streamlining a process that is meant to support students and walk away with what more learning outside the classroom. Questions a few assumptions and have more success discussion from faculty and recommendations. Yes, few stories to find an advisor we need to assure to find faculty for clubs and make sure there are incentives for advisors. The institution needs to make it easier so this discussion would see how Advisors can help with" red tape", wisdom and experience advisor can use with students. Certain things will need an advisor. If you want to reserve and use money by policy you need an advisor who is responsible for things students can't do alone.
