Rudy-Alumni on and off campus benefits. Past-there was a hold on benefits in 2019 (policies on campus changed). They are hoping to include CCP program- they would offer promotion through the foundation newsletter. A poll was done and most Alumni would prefer on campus benefits. Core focus is engaging with Alumni. Previously the cost for Alumni card was about \$15-20 a month or about \$200+ lifetime membership.

Alumni= anyone that has taken one class..maybe add has taken one class but not enrolled. They would also need to have a SID to qualify.
