- **A.** Student Body President: Met with the accreditation committee, which is recruiting up to 15 students to participate. Has been speaking to classes about SGA and recruiting SGA members and Assembly members to join the group.
- **B.** Executive Vice President of Legislation: Redwood empire food bank held a drive through food bank at SRJC Santa Rosa, and they had. Wanted to thank all students who came to speak during public comment, and reaffirms the importance of students' voices. SGA should assert their power to stand up for what's right regarding recent administrative decisions that went against bylaws.

- **D.** Vice President of Clubs, Santa Rosa: First virtual club day is on the 30th from 1:30 PM to 3:00 PM. This will be a test run for club days, to see what will work for future virtual events.
- **E.** Vice President of Clubs, Petaluma:
- **F.** Vice President of Student Life, Santa Rosa: Arts and Lectures committee will be having their first event of the year featuring local musician Eki Shola on September 28th and noon. Student Life Committee has moved to an every-other-week schedule
- **G.** Vice President of Student Life, Petaluma: Meeting with Lissett to discuss and plan a club day event for the Petaluma campus.
- **H.** Vice President of Marketing, Santa Rosa: Working with Nick on a last push for the census, including graphics for Bearfacts and social media. Talked with Michelle Vidaurri about getting students access to the backend of the SRJC App so that student leaders can post and make official announcements from official accounts.
- I. Vice President of Marketing, Petaluma:
- J. Vice President of Student Health: Today, met with the Health Promotion Meeting to discuss the low volume of appointments, and in response will be working on a student survey regarding accessing health services. Process is moving forward for hiring a black therapist. Working on getting a tile for student health on the SRJC app, and will be meeting with Michelle Vidaurri to discuss. PEERs will be screening a film, "The S Word". Attended the Mental Health board for the county and got more ideas for the upcoming election panel item.
- **K.** Vice President of Diversity: Queer Resource Center is interviewing new QRC student researchers. Working on attending each club's meetings to see what their needs are and how they can be supported.
- **L.** Vice President of Sustainability: Students Demand Action is hosting a voter registration drive, and the pregame starts at 5 PM following this meeting. The event will be tomorrow for voter registration day.
- **M.** Student Trustee: M.E.Ch.A. hosted a Board of Trustee candidate forum last week, and 2 candidates showed up to answer questions, 3 did not. The recording will be made available soon.
- **N.** President Emeritus (Five Minutes): Evelyn Navarro: Present to speak on behalf of a number of past SGA presidents. Speaking on behalf of past president Josh Pinaula, explained the past intention behind the SGA Code of Conduct, and their disagreement that it has been used by the administration against a student leader. Encouraged the SGA to address their code of conduct and amend it to clarify that it is not to be used that way in the future. Condemns the VP of Student Service's decision and explains that a decision was taken from the

students.

**O.** President Emeritus (Five Minutes): Lekkyes Dakwakas: Disappointed in current state of SGA and Student Life. Believes that the disqualification of a student body president and appointment of another was against the bylaws and is wrong. Believes that there has been prejudice shown by the current student president, and encourages the SGA to reassess what happened and work to address injustices in the administrative process .
