Are you ready for me? Making SRJC a STudent Ready College

Event scheduled for 11/18, 4pm - 6pm. Event is focused on the experiences of marginalized students. Facilitated by Anetra McCartney, SGA Student Trustee. Town hall setting. Listening session. Student panelists will answer questions about making SRJC STUDENT READY. This is part of SGA's engagement with academic departments.

Discussion questions:

- Seeking funding for student panelists. How much?
 - 1½ hour event for 11 panelists
 - Desire to pay speakers a living wage (19.50-40/hr). One suggested amount
- Should the event be "open mic"? Or closed session?
- How can we encourage senior leadership and faculty to attend? And stay in listening mode.
